mdex takes the protection of personal data very seriously and adheres strictly to the rules of data protection laws. Personal information is only collected the necessary extent. In no case, the data sold or transferred to any third party.

Please read the following data protection guidelines carefully before you access the mdex website. By using this site, you agree that mdex, in accordance to this data protection guideline, collect and process personal data. If you do not agree you should not use this site. mdex reserves the right to amend, to add or delate parts of this regulations. Your use of this website is subject to the terms of the current version of the mdex data protection guidelines at the time of use.

The following statement gives you an overview of how we ensure data protection and what type of data collected for what purpose.

Data processing on this website

mdex collects and stores in the server log files automatically information that your browser transmit while visiting our website. These are:

- ◆ ·Browser/ -version
- ◆ ·used operating system
- ◆ ·Referrer URL (previously visited page)
- ◆ ·Hostname of the accessing computer (IP address)
- ◆ ·Time of the server request

mdex cant't assigne these data to specific people. A compilation of these data with other data sources is not made, the data will be deleted after a statistical evaluation.

If you enroll on the mdex customerlounge, you'll be asked for personal data like your name and your email address. Optional data need'nt be specified. If you withhold these information, it may limit our options to offer you specific services. From the time when you registered your personal data have to be correct. When your personal data change after registration you have to update them immediately. If you miss, you may receive no benefits, no evidence or information from mdex.

mdex may use your personal and optional data (collectively as „user data“ named) for administrative purposes or improvements to this website, as defined in these data protection policies

All of mdex recorded data are bound for improved and precisely tailored benefits to our website visitors.

If you contract with the mdex on this website further personal data and/or optional data (such as address, phone number) will be assimilated, so we can give you certain benefits and a smooth running of our services can provide. The available data may be used by us to give you personal offers by email or regular mail.

Cookies

The web pages use in serveral places so-called cookies. They are used to make our offer more user-friendly, efficient and safer. Cookies are small text files placed on your computer and your browser. Most of the cookies we use are so-called „session cookies“. After your visit they'll be deleted automatically. Cookies don't damage on your computer and don't contain viruses.

Cookies are session specific text data stored on the user's computer. For any further access to the site, these text data will be conveyed to the server. There are two types of cookies: Cookies stored for each session and persistent cookies.

„Session cookies“ are deleted as soon as your web browser ends, the persistent cookies remain on the hard disk until the end of the expiry date, which is indicated at the first time-saving. These cookies are only sent to the server of mdex and contain no personal data but only an identification within our data processing on any session specific or personal data.

For the recorded data of mdex to improve the content and use of our websites, cookies are used only for the duration of a session. Persistent cookies are only used in the mdex customerlounge, so that in future visits on the site the appropriate content will be shown and you will save time. You can delete or block cookies in your browser.

Newsletter

If you want to receive the future offered newsletter on the website, we need an available email address as well as information that allow the checking of your email address (you are the owner and agree with the receiving of the newsletter). Further data will not be required. Your consent to the storage of data, email address and their use for sending the newsletter can be cancelled at any time.

Right of access to personal data

At any time you have the right of information about your stored personal data, their origin and destination and the purpose of data processing. Information on the stored data can be found at datenschutz@mdex.de.

Occasionally we send email messages or mailings to provide you useful information. These include information about new mdex products or services.

Our guidelines only allow the sending of email messages or mail to customers that gave their permission. email or mail from us always contain instructions on how to stop receiving mails or emails from mdex.

In general, user data are stored until we receive your dismissal, or until the expiry of any effectiv statutory periods. You can always interrogate stored data and request the amendment or deletion of data. Please contact the relevant contact information on the website or datenschutz@mdex.de.

mdex don't gives user data to third parties unless mdex act in good faith that this is lawful or to protect mdex rights or property. mdex guarantees that the information are only available for the user which they initially entered, our authorized partners and mdex themselves. These partners agree with mdex data protection guidelines and also observe the data protection laws. mdex website contain links to other sites that are not subsidiaries of mdex.
